In consideration of Creators for Creators (the organization) acceptance for review of my grant application, I agree to the following:

1. I represent that I am a sole or joint owner of the Materials included in this application as indicated above. Submission of the Materials does not conflict with the rights of, or any agreement I have or will have with, any third party except those resulting from my status as a joint owner with the individual(s) indicated above. If any additional third party makes a claim to ownership of any part of the Materials, I agree to notify Creators for Creators immediately.

I understand that Creators for Creators, including its directors, officers, staff, and volunteers, may review the Materials submitted for the purpose of determining, in its own discretion, whether to make a grant award to me. Creators for Creators agrees that it will not use, distribute, or copy the Materials other than as necessary to complete its review and determination under the grants program unless I agree otherwise. I acknowledge that the directors, officers, staff and volunteers of Creators for Creators may coincidentally develop ideas and artwork similar to the Materials submitted or similar to elements of the Materials submitted and I agree not to bring any claim against Creators for Creators with respect to such coincidentally similar materials.

3. In submitting the Materials, I understand that the only obligation incurred by Creators for Creators is to consider them for review as part of its grant program. The organization is under no obligation to award me any funds or compensation or to provide me any mentorship. If I am awarded the grant, I understand that Creators for Creators has discretion as to the amount awarded and in the case of joint works, may allocate the grant award disproportionately between owners. I also understand that Creators for Creators is under no obligation to continue the grant program or to issue any grant to any individual or individuals in any particular year. The organization's review of the Materials shall not be an admission of their value, novelty, or originality.

4. Creators for Creators may retain a copy of the Materials submitted. If any original or physical copies of the Materials are submitted pursuant to this grant application, Creators for Creators will be under no obligation to return those originals or copies to me or to protect such originals or copies from loss or damage.

5. I agree to indemnify and hold harmless Creators for Creators from and against all liabilities, claims, damages, costs, and expenses (including reasonable legal fees and expenses) arising out of or in connection with the submission of the Materials and information in this application and the breach of any representations and warranties in this Agreement.

6. I represent and warrant that I am eighteen years or older.

7. This Agreement shall be governed by, construed and enforced in accordance with, and subject to, the laws of the State of California. I waive any right I may have to seek injunctive or other equitable relief.

8. I understand that this Agreement is the entire agreement between Creators for Creators and me and it supersedes any prior understanding between us with respect to the subject matter of this Agreement. No modification of this Agreement will be valid unless it is made in writing, and signed by Creators for Creators and me. In the event that any part of the Agreement is found to be invalid, that portion of the Agreement shall be severed, and all remaining terms and conditions shall remain in full force and effect. This Agreement is binding on me and my heirs, assigns, successors, personal representatives, and executors.
